



PUBLIC MEETING NOTICE **CARSON COUNTY EMERGENCY SERVICES DISTRICT NO. 2**

Notice is hereby given that **Carson County Emergency Services District 2** will hold a public meeting on **July 21, 2026, at 7:00 p.m.**, at the **White Deer Fire Department**, located at **207 Omohundro Street, White Deer, Texas 79097**.

The District will consider and act upon the following matters:

1. Call meeting to order, roll call and establish a quorum.
2. To receive public comments.
3. To approve the Minutes of prior meeting(s).
4. To review, discuss, and take action on the District Financial report and take any necessary action regarding the District's investments, and payment of the District's bills including quarterly service provider payments.
5. To review, discuss and propose the District's 2027 Budget.
This is an item to begin the Budget adoption process for the upcoming FY 2027. The District acknowledges the requirement of Government Code §551.043(c)(2) to prepare a taxpayer impact statement when reviewing and adopting budgets. However, certified values are not yet available and the required no new revenue tax rate calculations are not yet available. Therefore, no Taxpayer Impact Statement is included.
6. To review, discuss and propose the District's 2026 Tax Rate.
7. To schedule a public hearing regarding the District's 2026 tax rate and the date of the meeting to adopt.
8. To review and take action on matters relating to an election to be held on November 3, 2026:
 - a. Approve an Order of Election under Texas Tax Code Section 26.07.
 - b. To review and take action to hold an election jointly with other jurisdictions.
 - c. To review and take action to contract with Carson County Elections Office for election services.
 - d. To consider and take action on such other Orders, Resolutions and related matters as required or appropriate to call for the District election

9. To authorize District Counsel to publish any necessary notices related to the District's 2026 tax setting process.
10. To review, discuss and take action regarding District Service Provider budgets.
11. To receive June 2026 reports from District Service Providers and take any necessary related action.
 - a. City of White Deer VFD
 - b. Groom VFD
 - c. Skellytown VFD
12. To review, discuss and take action regarding the dispersal of payments from Hutchinson County related to SS Fire FMAG.
13. To review, discuss and take action regarding an Interlocal Agreement with the City of White Deer.
14. To review, discuss and take action regarding the District's current Ad Valorem Tax Report.
15. To review, discuss and take action regarding the 2026 District SCBA Capital Project.
16. To review, discuss and take action regarding an Interlocal Agreement with Texas Facilities Commission.
17. To review, discuss and take action regarding upgrades for District radio infrastructure and dispatching matters.
18. To review, discuss and take action to confirm the date for any future meetings including the next regular District meeting, and to discuss any agenda items needed for those meetings.
19. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel.
20. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
21. To review, discuss and take action on matters discussed in Closed Session.
