

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.100000 per \$100 valuation has been proposed by the governing body of **CARSON COUNTY EMERGENCY SERVICES DISTRICT NO.2.**

PROPOSED TAX RATE	\$0.100000 per \$100
NO-NEW-REVENUE TAX RATE	\$0.108007 per \$100
VOTER-APPROVAL TAX RATE	\$0.113945 per \$100
DE MINIMIS RATE	\$0.204098 per \$100

The no-new-revenue tax rate is the tax rate for the 2026 tax year that will raise the same amount of property tax revenue for Carson County Emergency Services District No.2 from the same properties in both the 2025 tax year and the 2026 tax year.

The voter-approval rate is the highest tax rate that Carson County Emergency Services District No.2 may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for Carson County Emergency Services District No.2 exceeds the voter-approval rate for Carson County Emergency Services District No.2.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for Carson County Emergency Services District No.2, the rate that will raise \$500,000, and the current debt rate for Carson County Emergency Services District No.2.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Carson County Emergency Services District No.2 is not proposing to increase property taxes for the 2026 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON AUGUST 21, 2026, AT 6:00 PM AT 207 S. OMOHUNDRO STREET, WHITE DEER, TEXAS 79097.

CARSON COUNTY EMERGENCY SERVICES DISTRICT NO. 2 SHALL TAKE ACTION ON THE PROPOSED TAX RATE ON AUGUST 21, 2026, AT 6:00 PM FOLLOWING THE HEARING TO BE HELD.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Carson County Emergency Services District No. 2 is not required to hold an election to seek voter approval of tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Commissioners of Carson County Emergency Services District No. 2 at their offices or by attending the public hearing mentioned above.
